



Professor Mari Womack (2005) begins his book on “Symbols and Meaning”: “Tonight, in this city, someone will die for symbols”. On its peripheral reading, it looks that Professor Womack is exaggerating the importance of symbols. But if someone tries to learn the symbols and its importance, then one will surely find that what the professor is trying to say is something beyond our normal idea of the meaning of symbols. He tries to tell us that there is no “just a symbol”. Symbols play a dominant role in everyone’s life. Our life is full of symbols and through them we try to ascertain our identity. This can be perceived more vividly when one becomes the member of a particular group, society, an association or an organization. We are involved with the multiple layers of symbols of religion and magic, symbols used in mass media like television, movies, and advertisements. There is no possibility that we can escape from symbols in our lives; at least we bump into them in our dreams. Symbols are part of our psyche, our culture, our religion, our language, art and literature, and our entertainment.

To know the deeper meaning of our liturgy - sacrament and worship, we need to explore the true meaning of the symbols we use. The direct object of religion (its philosophy or theology) is not God: the direct object is God’s manifestation to us which is brought about through the expressions of religious symbols. The object of religion is found in the symbols of religious experience. Everything that the religion uses (symbols) for God, points to God. Hence the direct object of religion is found only in religious symbols.

The early Christians have taken most of their symbols from the ancient Jewish religion, near eastern religions and later from the Roman world. Natural things like bread, wine, vine, water, oil, rock, tree, sun and moon, fire and light etc. were important phenomena of their lives. Their stories are full of these rich symbols. And early Christians retained most of these ancient symbols. They see in God and Jesus their good shepherd. Christ is seen as a lamb, a unicorn, and a fish, each expressing its own unique meanings.

The more we understand the roots of symbols and their meaning the better becomes our worship and rituals. In our rituals, we will be able to join with our community, with

the nature, with the entire universe in worship of our God. Symbols bring life and richness to our mundane life.

Do our symbols that we use in our worship still nourish us and our relationship with our Creator God? As Catholic Women's League, how do we make relevant our organization and the religious values on which rest all our activities?

Hello League Sisters,

It is my privilege to serve the Hamilton Diocesan Council as President Elect and Organization Chair.

My role and responsibilities as President Elect and Organization Chair cover five key functions, which are: Leadership Development - Recruitment of members and maintaining membership - Annual Reports Life Membership – and League Resource Material.

I would like to highlight a few changes as a result of the instructed votes, and draw your attention to some important timelines, League bylaws, and policy and procedures as they pertain to membership and the nominations and elections process.

Under the new structure of the League, the position of President Elect and Organization Chair has been replaced with the new First Vice President and Organization Chair position. This change is part of the newly Adopted amendments that changes the number of positions and chairs on an executive council.

Councils will transition to the new structure when their terms two-year terms are up and they hold their next council election at their January or February Annual Meeting of Members. In the interim, councils will serve out their two-year terms under their current structure in accordance to their current roles and responsibilities.

## **MEMBERSHIP FEE and the NEW PER CAPITA FEE**

### *MEMBERSHIP FEE*

Your Membership Fee is due January 1st annually. Although this is not new, this is a reminder to ensure your membership fees are paid by January 1st each year.

This will ensure that you are in good standing and maintain your rights as a member.

“Membership is established and maintained by payment of the annual prescribed membership fee through a local parish council in accordance with Part XVII, Section 4 of the League’s Bylaws. Part XVII 4(a) “A membership fee is determined by each individual parish council and shall be due on January 1.”

*NEW PER CAPITA FEE*

Parish, Diocesan, and Provincial Councils across Canada were asked to vote on a membership fee increase via an instructed vote from National. A majority vote of membership across Canada voted in favour of the membership fee increase. At the National Convention in August 2022, the instructed vote for membership fee increase was Adopted.

The new Per Capita Fee is broken down for the Hamilton Diocesan Council as follows:

-National: \$25.00 (Plus insurance)

-Ontario Provincial: \$3.00

-Hamilton Diocesan: \$6.00

-SUBTOTAL: \$34.00

-Parish Council FEE Varies per council. Adding the portion of your Council FEE will give you your new Membership Fee for 2023.

*MEMBERSHIP DRIVES, RECRUITMENT AND MAINTAINING MEMBERSHIPS:*


Connectedness and getting back to the grass roots of giving our efforts that personal touch is so important for both membership recruitment, maintenance and retainment.

League executives are all levels are working hard on innovative initiatives to address our membership decline across the country. I have been working on a few initiatives for our diocese and have shared several of my ideas with my provincial and diocesan counterparts as part of a provincial organization working

group. Together, we are brainstorming and developing innovative ways to address membership concerns, retain our members, and grow our membership. We are also looking into the possibly holding a diocesan or provincial wide membership drive. I encourage councils to continue holding membership drives, promote the League in your parish bulletins and on social media, including reaching out to our youth, as membership eligibility begins at age 16.

At the spring regional meetings 2023, we will present councils who report to me an increase in membership from 2002 to 2023.

### *ANNUAL REPORTS*



National sent Parish Councils information and link information for completing their 2022 annual reports. Parish Councils have the option of completing their reports either manually or electronically.

The deadline for completing annual reports is December 15, 2022 for paper copies and midnight on January 15, 2023 for completing it online.

### *NOMINATIONS AND ELECTIONS*

To ensure an easy transition to the new structure of the League executive for our parish councils, I have revised the Nomination & Elections Package that I created to reflect these changes and will make it available to councils. In addition, I am offering another nomination and election information/training session via Zoom this month. I am particularly encouraging those councils nearing the end of their two- year term and are required to hold nominations for an election at their January or February 2023 Annual Meeting of Members. Information will be

shared with parish council presidents to share with members. Interested members may also contact me directly at [presidentelect@cwllhamilton.ca](mailto:presidentelect@cwllhamilton.ca)

### *PARISH ELECTIONS*

Parish elections are to be held in January or February at the parish council annual meeting of members, in accordance with the League's Constitution and Bylaws.

### *TERM LIMITS*

At parish, diocesan, provincial, and national levels, the term of office for elected or appointed officers is two years. Parish Councils must hold nominations and elections every two-years in accordance with the League's Bylaws.

### *TIMELINES FOR THE NOMINATIONS AND ELECTIONS PROCESS:*

According to our Manual of National Policy and Procedures, the Nominations and Elections process for Parish Council is the following timeline:

November:



- President appoints a Chair and two other members to form a Nominations & Elections Committee.
- Secretary provides Committee Chair with the Elections Register (Names of all members and positions they have previously held).
- Committee puts together Eligibility List based on Elections Register.

December:

- Committee sends out Nominations & Elections packages to each member and sets a deadline to return nominations.

January:

- Chair contacts nominees to confirm their acceptance of the nomination and prepares an Elections List and ballots for upcoming Election.

January or February:

- Elections are held at the Annual Meeting of Members.

### *VIRTUAL MEETINGS*

Virtual meetings are *not permitted*. You may gather virtually with members and have a chat, but meetings must be held in person to conduct League business. Since virtual chats are not considered meetings, there is not an agenda or minutes.

### *AT YOUR SERVICE*

In order to serve you better and to ensure our records are accurate, I sent out an information request via our Regional Chairs to each parish council. The information being sought is: an up-to-date listing of parish council executives along with their emails, the number of members in each council, the date of the parish council's last election, and if their Spiritual Advisor attends their meetings. Please remember to send me updated information when there is a change to your executive councils.

### *IN CLOSING*

I encourage every member to read up on and learn your roles and responsibilities as an executive member and also as a member of the League. You can do this by reading our League's governing documents, attending leadership development opportunities, attending meetings and conventions, and by asking questions.

The League's C&B and National P&P are being updated to capture the new amendments that were adopted at the National Annual meeting of members August 2022. Two complimentary copies of the revised C&B will be sent to each council President and Secretary and additional copies will be made available for purchase.


## St. Andrew, Oakville

Centennial Celebrations for St. Andrew's CWL (1922-2022)

In 1922, a small group of faith-filled women from St. Andrew's founded the first CWL council in Oakville. Our centennial has provided us with the wonderful opportunity to honour and retell our CWL story with our parish community, and the resulting celebrations have brought many blessings. We began the year by announcing it with prayer cards for all parishioners, a banner, and outdoor signage. Beginning then, and throughout the year, we have used as our trademark a photograph of the Annunciation window, installed just over 100 years ago by our League's predecessors, the parish Altar Society.

We eased our way back into an in-person meeting by gathering for an evening Mass in February with a special talk from Halton Alive. In March, we sewed mite bags for all interested parishioners to keep in a visible place in their homes so they could collect their family's Lenten offerings for the St. Vincent de Paul Society. In April, we treated ourselves to a motivational speaker, and CWL member from Mary Mother of God parish, who lifted our spirits with stories of faith, resilience, and humour.

In May, the 100 tulip bulbs that we planted in the fall bloomed in our new commemorative garden. We were also delighted to welcome parishioners and CWL members throughout Oakville to two special events. Our 12 Hours of Prayer for Palliative Care (with all day Exposition of the Blessed Sacrament) began with Mass, continued with individual and group prayer (Rosary and a palliative doctor's



meditations on the Stations of the Cross), and culminated in a beautiful celebration of Benediction where we were joined by the parish choir.

We also celebrated an Outdoor Rosary accompanied by our children's choir and well attended by families and visitors from babies to nonagenarians. Our Lady blessed us with beautiful weather for all our events including our June retreat to the Carmelite convent, parish church and shrine in St. Agatha, and to St. Mary's in Kitchener (with a delightful shopping stop in St. Jacob's for lunch); our July presentation of a commemorative bench to the parish complete with an anniversary cake cutting; our Mass and 1920s-themed "high" tea to celebrate the Feast of the Assumption; and our special Mass with Bishop Crosby followed by lunch in September.

During the year we have also had a couple of small fundraisers – "Plantables" in the spring and handmade dishcloths this fall. We wind down our year with a Memorial Mass for deceased CWL members on the Feast of all Saints. For all our events we were also blessed to have the great support of our Pastor Father Con O'Mahony and our Associate Pastor Father Felix Nwatu.

We would like to invite all CWL members from Oakville, and beyond, to join us for an Advent liturgy on Tuesday, November 29, at 7 p.m. so that we can once again celebrate together the gift of our Women's League with the larger Catholic community of Oakville as we await in hope, faith, joy, and peace for the Coming of Our Saviour.


